We are pleased to inform you that we will be accepting a limited number of new applicants for the up-coming school year. Enclosed are a few copies of the new application form that you may copy and distribute to interested parents.

The eligibility guidelines for the 2010-2011 school year have not changed. They are:

1. Residence must be in Hartford, Bridgeport or New Haven.
2. New students must be in grades K through 5.
3. Household income must be within the eligibility limits as indicated on the application form.
4. Scholarship awards will be one half of the tuition per student up to \$1,900.

Completed applications must be returned **by mail** and will be considered on a first-come, first-serve basis. To be complete, an application must be filled in, signed by a parent or guardian and include copies of the 2009 IRS Form 1040 for each wage earner in the household.

We thank all of our participating schools for your support and cooperation. We look forward to working with you for the benefit of our scholarship recipients.

Eligibility Requirements:

1. You must currently reside in Hartford, Bridgeport or New Haven.
2. Your student must be going into grades K-5.
3. Your household income must be at or below the limits listed for your household size:

Household Size 2 – Income Limit = \$30,000

Household Size 3 – Income Limit = \$37,500

Household Size 4 – Income Limit = \$45,000

Household Size 5 – Income Limit = \$52,500

(for larger households, add \$7,500 per person)

Instructions:

1. Complete, sign and mail this application to the address shown above.
2. Attach copies of all household wage earners' 2009 IRS 1040 forms.

If you did not file a 1040 form, you must provide us with a signed affidavit stating that no one in your household filed a 2009 Form 1040 and explaining the reason why no filing was made. Attach evidence of unemployment, copies of DSS or Social Security Administration budget sheets or checks, etc. **Please note that W-2 and pay stubs are not accepted.**

Applications not accompanied by the required proof of income will be deemed to be incomplete and will not be considered until satisfactory income documentation is provided.

Completed applications will be considered on a first-come first-serve basis. Incomplete applications will not be processed. You will be notified in writing if you are awarded a scholarship. Scholarship awards are calculated as one half of actual annual tuition up to a maximum annual award of \$1,900 per student. Awards are paid directly to the schools.

I agree to the following terms and conditions in the event that my child is awarded a scholarship by Children's Educational Opportunity Foundation of Connecticut: 1) I will remain current on all tuition and fee payments to the school that my child attends; 2) Scholarship payments will continue only as long as my child is enrolled in a private or parochial school and attending school regularly; 3) All scholarship awards are made in the sole discretion of CEO Foundation of Connecticut; 4) I grant permission to the school I select to send CEO Foundation of Connecticut copies of my child's past, present and future school records; 5) I will promptly notify CEO Foundation of Connecticut of any change in address; and 6) I agree to release CEO Foundation of Connecticut from any liability in its efforts to provide this scholarship.
